# **Job Summary**

Telework available and negotiated at the time of hire.

Under limited supervision, this grant-funded position works with Minnesota State colleges and universities to coordinate with the Minnesota Department of Employment and Economic Development (DEED) in expanding educational opportunities to incarcerated individuals in federal prison facilities and those in transitional facilities. Working with the Director of Student Access and Academic Partnership, internal and external partners and other system office staff, will work to create opportunities for state and federal expansion of educational opportunities, including dual enrollment opportunities, and support the delivery of academic programs (currently Business and Entrepreneurship Certificates) within federal facilities, including capturing learning to inform future teaching and program delivery to incarcerated populations. This position will be responsible for identifying key policy and procedure considerations to support the participation and expansion of Minnesota State college and university partners, as well as identifying the organizational and systems change needed to support larger numbers of students – this work may include research, strategy development and other work to support

education for those within the criminal justice system. The position will support the PROWD project by assisting campuses in working through system policies, procedures, and operating instructions to successfully expand opportunities for students to achieve their educational goals.
