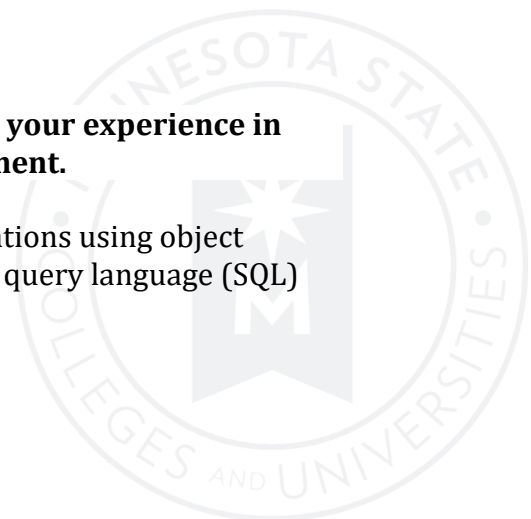
#### **Job Summary:**

The successful candidate will participate in the development and maintenance of responsive web applications using Java/Java EE/Spring/Grails technologies and frameworks. If you want to work with a smart, dedicated team and leverage your object oriented development skills, this St. Cloud, MN position may be right for you.
