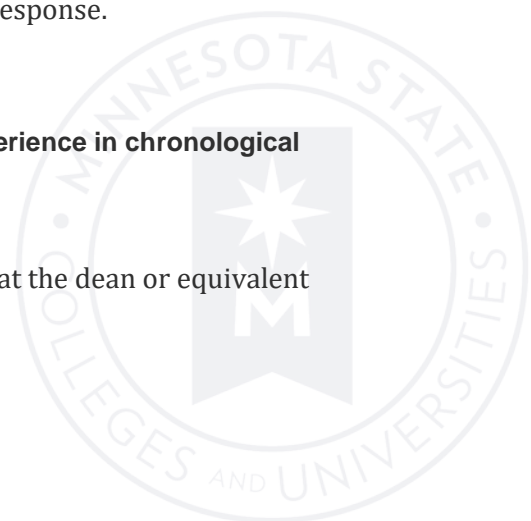
Job Summary:

The position responds, in partnership with Minnesota State colleges and universities, to opportunities to coordinate educational programs that offer work-based or experiential learning, attainment of industry-recognized credentials, competency-based education, career-technical education, and other approaches to workforce development. Social Security number, birth date, age, gender, and date of high school graduation. **Foreign transcripts** must include an official transcript evaluation which interprets equivalency to U. S graduate credits.
 - If you scan your transcript, please make sure that it is readable before you attach it to your application. If you do not submit your transcripts(s), you will not be considered.
