TRANSFER AGREEMENT  
BETWEEN

Rochester Community and Technical College  
AND  
Winona State University

\*The Board of Trustees of the Minnesota State Colleges and Universities is authorized by Minnesota Statutes, Chapter 136F to enter into Agreements and has delegated this authority to colleges and universities.

This Agreement is entered into between **Rochester Community and Technical College [851 30<sup>th</sup> Avenue Southeast, Rochester, MN 55904]** (hereinafter sending institution), and **Winona State University [175 West Mark Street, Winona, MN 55987]** (hereinafter receiving institution). This Agreement and any amendments and supplements, shall be interpreted pursuant to the laws of the State of Minnesota.

The sending institution has established a **Computer Information Systems A.S.** (hereinafter sending program), and the receiving institution has established an **Applied Computer Science – Computer Information Systems Emphasis B.S.** (hereinafter receiving program), and will facilitate credit transfer and provide a smooth transition from one related program to another. It is mutually agreed:

#### Admission and Graduation Requirements

- A. The receiving institution's admission and program admission requirements apply to both direct entry students and to students who transfer under this agreement.
- B. Students must fulfill the graduation requirements at both institutions.
- C. Students must complete the entire sending program and meet the receiving institution's admission requirements for the agreement to apply, including grade requirements for courses and an overall GPA requirement.

#### Transfer of Credits

- A. The receiving institution will accept **60** credits from the sending program. A total of **60 credits** remain to complete the receiving program.
- B. Courses will transfer as described in the attached Program Transfer Table. For system institutions, once the courses are encoded, they will transfer as described in the "Transferology" audit.

#### Implementation and Review

- A. The Chief Academic Officers or designees of the parties to this agreement will implement the terms of this agreement, including identifying and incorporating any changes into subsequent agreements, assuring compliance with system policy, procedure and guidelines, and conducting a periodic review of this agreement.
- B. This Transfer Agreement is effective on **01/15/2023** and shall remain in effect until **01/15/2028** or for five years, whichever occurs first, unless terminated or amended by either party with 90 days prior written notice.
- C. The college and university shall work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.
- D. This Transfer Agreement will be reviewed by both parties beginning **07/15/2027** (within six months of the end date).
- E. When a student notifies the receiving institution of their intent to follow this agreement, the receiving institution will encode course waivers and substitutions.

Describe program admission requirements (if any)		All courses must be taken for grade, and only a minimum grade of "C" will be acceptable. To be considered for admission, students must have a minimum 2.5 GPA.

### Instructions

- List all required courses in both academic programs.
- MnTC goal areas transfer to the receiving institution according to the goal areas designated by the sending institution.
- Do not indicate a goal area for general education courses that are not part of the MnTC.
- For restricted or unrestricted electives, list number of credits.
- Credits applied: the receiving institution course credit amount may be more or less than the sending institution credit amount. Enter the number of credits that the receiving institution will apply toward degree completion.
- Show equivalent university-college courses on the same row to ensure accurate DARS encoding.
- Equiv/Sub/Wav column: If a course is to be encoded as equivalent, enter Equiv. If a course is to be accepted by the university as a "substitution" only for the purposes of this agreement, enter Sub. If a course requirement is waived by the receiving institution, enter Wav. If a course is to be accepted by the university as a MnTC goal area, restricted elective or unrestricted elective, leave the cell blank.

### SECTION B - Major, Emphasis, Restricted and Unrestricted Electives or Other

(pre-requisite courses, required core courses, required courses in an emphasis, or electives (restricted or general) within the major). Restricted electives (in Major) fulfill a specific requirement within a major. Example A: “Chose two of the following three courses;” Example B: A Biology degree may require 40 science credits (20 credits of required courses + 20 credits of listed related courses, such as botany, genetics, sociobiology, etc. which students can select).

**Special Notes, if any:**

Winona State University requires:

- A minimum of 40 required semester hours (credits) for the baccalaureate degree at the upper-division (300-400) level. If a lower division course is shown as equivalent to an upper division course, check with the university to determine if it will count toward the 40 required credits of upper division.
- A minimum of 30 credits out of the last 60 credits to be completed at Winona State University.
- All **major emphasis** courses taken for grade.
- A minimum grade of "C".
- A cumulative grade point average of at least 2.5 GPA for the courses taken while enrolled at RCTC.
- A minimum WSU GPA of 2.50 and an overall cumulative GPA of 2.50 required.
- A minimum GPA of 2.50 required in the major.
- Students may attempt CS course at most 3 times.
- Students must complete at least 18 credits of 300-400 level CS courses with at least 12 credits beyond the Computer Science core requirements at WSU.

The following limitations also apply:

- Developmental courses shall not be counted toward graduation.
