



The following report displays South Metro's <u>actual performance</u> for grant years 1-4 (2021-2024) and <u>proposed state determined levels of</u> <u>performance</u> (SDPLs) for grant years 5-8 (2025-2028). **Table 1** provides data for *secondary* performance indicators. **Table 2** provides data for *postsecondary* performance indicators.

Requirements for state determined levels of performance require that new performance targets/SDPLs must:

- Be expressed as a percentage or numerical form.
- Show continuous meaningful progress toward improving performance of all career and technical education students.
- Be higher than the average actual performance of the two most recently completed program.

For more information on actual performance during grant years 1-4 (2021-2024) please review your consortia's annual performance report.

New guidance from the US Department of Education on 113(b)(3)(A)(III)(ee) from the Strengthening Career and Technical Education for the 21<sup>st</sup> Century Act requires us to set state determined levels of performance (SDPLs) "higher than the average actual performance of the 2 most recently completed program years" for *each* subsequent year of the plan. Therefore, while the SDPLs on page 2 will be implemented whenever possible, they may be adjusted for grant years 6 through 8 (2026-2028) based on actual future performance as outlined below:

- **GRANT YEAR 5:** Stated SDPLs (condition already met and approved by OCTAE).
- GRANT YEAR 6: Stated SDPLs <u>OR</u> the average performance from grant years 3 & 4 (2023-2024) + 0.01%, whichever is <u>higher</u>.
- GRANT YEAR 7: Stated SDPLs OR the average performance from grant years 4 & 5 (2024-2025) + 0.01%, whichever is higher.
- GRANT YEAR 8: Stated SDPLs <u>OR</u> the average performance from grant years 5 & 6 (2025-2026) + 0.01%, whichever is <u>higher</u>.

This is indicated on page 2 with the  $rac{1}$  symbol before any SDPL in which this rule applies. Adjustments due to unanticipated circumstances outside of this will still be possible, when applicable. With the state plan approved by OCTAE, grant year 5 performance levels are now final.
