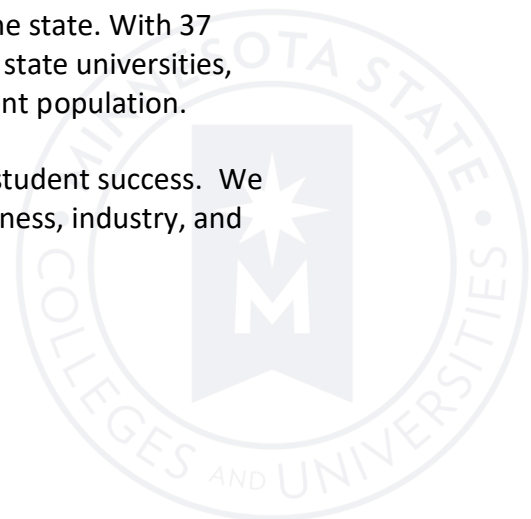
Job Summary:
